My name is Eric, and today my wife went to vote at her precinct in Dortches. I encouraged her to vote early, but she never got a chance. She arrived today, and they almost made her cry! They complained that she's registered as an independent, and sent her back and forth from the registration table to the ballot table to the exceptions table. They questioned which ballot she should receive, then questioned again, until they finally sent her to the wall to pick out her own ballot, stating that they were unsure what to give her because she was registered as an independent. I am OUTRAGED. I am tempted to contact that ACLU, and that State Board of elections. A voter should never be standing, almost in tears, because untrained idiots are working that polling place. In a general election, what does party affiliation have to do with the price of eggs in China? Nothing! Everyone gets the same ballot in the same precinct and can choose the candidates of their choice, regardless of party. Now my wife's ballot may be discarded because she may have voted on the wrong ballot- she was forced to choose her own. That is disenfranchisement at its best, and is a terrible shame. Please contact me via email so we can discuss how to fix this and make sure she got the right ballot before I have to file a complaint. I'm a teacher and will be unavailable by phone.

Hi John, I wanted to relay a call I took from a Nash County voter who called to complain that she was turned away on Election Day. The voter's name is Evelyn Jean Proctor at 6894 Randy Lane in Rocky Mount. Ms. Proctor appeared to vote at the Nash Agricultural Center polling place around 8:30 a.m. on Election Day. Her name was not found in the pollbook there. No issue there – it appears that she showed up at the wrong polling place, as her registration record shows her proper polling place being Nash Central High School. The pollworkers said she wasn't on the list and apparently told her where to go, which she wasn't very happy about because she is elderly.

The issue, however, is that the pollworker's explanation for why Ms. Proctor was not on the voter rolls was because she didn't vote in the primary this year. Obviously, that would not be accurate to say. Also, she was not offered a provisional ballot (and because she is registered in Nash County at her correct address, that provisional ballot could have eventually be counted in full or in part).

That's just one side of a story, and it sounds like she may have become confrontational at that point, but I did want to pass this report along. If you do wish to follow up further with Ms. Proctor, her phone number is 252-443-6679.
