Enclosed is the initial report of electioneering communications filed by the Natural Resources Defense Council (NRDC). As part of a coalition with Southern Environmental Law Center (SELC) and other organizations under the umbrella of the North Carolina Environmental Partnership, NRDC has distributed communications examining the environmental policies of various North Carolina legislators. These communications focus on the legislators' positions on fracking, an environmentally risky method for extracting natural gas from the earth. The communications encourage North Carolinians to contact these legislators regarding their past votes to allow fracking and weaken environmental safeguards, with the aim of getting these legislators to change their position on the potentially damaging practice of fracking. For the reasons set forth below, we do not believe NRDC's activities qualify as electioneering communications under North Carolina law, but we file this report in the spirit of transparency and based on informal advice received from State Board of Elections staff.

NRDC and its coalition partners are focusing on legislators who in the past have supported allowing fracking without appropriate safeguards. We want their constituents to urge them to halt this harmful activity. The communications are timed to precede the upcoming legislative session, when legislators may have an opportunity to protect North Carolina families from fracking. Although no fracking legislation is pending, and it is unknown whether any will be introduced, NRDC hopes that by encouraging North Carolinians to contact these legislators about fracking, the legislators will, in turn, work to protect our clean water and families' health from unsafe fracking if the opportunity arises during the upcoming session.

State law defines "electioneering communication" as including a TV ad or mass mailing that refers to a clearly identified candidate for elective office, may be received by an audience of a specified size, and occurs during a specified window of time before "an election for that office." N.C. Gen. Stat. § 163-278.6(8j). NC SCBE staff informally advised a coalition partner's attorney that because the communications will be distributed in the weeks before the May 6 primary election, they must be reported as "electioneering communications."

NRDC distributed these communications without regard to the timing of any elections. In fact, no legislator named in these communications appears on a primary ballot. For that reason, it seems peculiar that the communications would be treated as "electioneering communications." The purpose of requiring disclosure for electioneering communications is to inform the public about efforts to influence elections. Where legislators face no opposition in their primaries and therefore do not appear on the ballot, there is no election to influence. Interpreting the term "electioneering communication" to require disclosure of communications that name a candidate who is not on the ballot is inconsistent with the General Assembly's intent in passing this law.

Staff at the State Board of Elections informally advised that the Board treats a communication as an electioneering communication whenever there is any election for a particular office, even if the candidate named in the communication is not on the ballot. The communications identify State Senators Chad Barefoot, Wesley Meredith and Ronald Rabin. Not only do Senators Barefoot and Meredith face no primary opponents, but their general-election opponents themselves face no primary opponents. So in the cases of Senators Barefoot and Meredith, there is no primary election for any candidate for their offices. Because there is not "an election for that office" on May 6, communications that mention those two legislators are not "electioneering communications" with respect to those individuals.¹ In the case of Senator Rabin, two candidates in an opposing party filed to run against him, so there will be a primary election on May 6 for his office.

Based on the NC SBE staff's informal interpretation of the electioneering communications statute, NRDC is disclosing as electioneering communications the costs related to the portion of the communications that identify Senator Rabin.


¹ An alternative interpretation of the statute could be that "for that office" refers not to the specific senate office the candidate seeks, but rather to the office of state senator generally. However, this broader interpretation would lead to absurd results. For example, if a senate seat were to become vacant and a special election were held to fill that office, communications before the special election that named other senators and that were distributed in other parts of the state would become reportable electioneering communications solely by virtue of the fact that a special election was being held somewhere else in the state.






